

A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR AND THE FINANCE DIRECTOR TO ENTER INTO AN AGREEMENT WITH KENWORTH OF RICHFIELD FOR THE PURCHASE OF A NEW 2020 T370 SINGLE AXLE PLOW TRUCK CHASSIS WITH ALL SNOW PLOW EQUIPMENT, WAIVING COMPETITIVE BIDDING, AND DECLARING AN EMERGENCY

WHEREAS, the Village is a member of the National Joint Powers Alliance (NJPA) which is a municipal contracting agency that serves governmental agencies through competitively bid and awarded contract purchasing solutions that permit municipalities to take advantage of lower costs than municipalities would otherwise receive; and

WHEREAS, pursuant to the Village's Charter and state law, this Council has the authority by legislative enactment such as this Resolution to authorize a purchase through a joint purchasing program, such as NJPA; and

WHEREAS, through the NJPA, the Village wishes to purchase a new 2020 T370 Single Axle Plow Truck and Chassis with all snow plow equipment from Kenworth of Richfield; and

WHEREAS, the truck and equipment are being purchased pursuant to Hissong Kenworth NJPA/Sourcewell Contract No. 0181716-KTC.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the Mayor and the Finance Director are authorized and directed to enter into an agreement with Kenworth of Richfield through the NJPA for the purchase of a new 2020 T370 Single Axle Plow Truck Chassis with all snow plow equipment pursuant to the proposal incorporated in the Director of Service and Engineering's memo attached hereto as Exhibit "A" and incorporated herein by reference in the amount \$205,613.00.

SECTION 2. That because this purchase is made through the NJPA, this Council waives the requirements for competitive bidding or other quote requirements pursuant to Section 141.03(f) of the Richfield Codified Ordinances.

SECTION 3. That the funds for the purchase are already appropriated in the Capital Improvement Fund, Account D18-06B-257.16.


SECTION 4. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary due to the long lead time in acquiring this type of truck and equipment in order to have the truck with the plow available at

the earliest possible time; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
