

**RESOLUTION NO. 47 -2014**

**Offered by All of Council**

A RESOLUTION AUTHORIZING THE MAYOR AND THE FINANCE DIRECTOR TO ENTER INTO AN AGREEMENT FOR DISPATCH SERVICES WITH THE VILLAGE OF PENINSULA AND DECLARING AN EMERGENCY.

WHEREAS, the Mayor has recommended entering into an Agreement with the Village of Peninsula for dispatch services for three (3) years commencing July 1, 2014 through June 30, 2017.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the Mayor and the Finance Director be, and they hereby are, authorized and directed to enter into an Agreement with the Village of Peninsula for dispatch services for three (3) years commencing July 1, 2014 in accordance with the Agreement attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to pay for services rendered; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor: otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

## EXHIBIT A

**DISPATCH SERVICE AGREEMENT**

Pursuant to R.C. 737.04 and 737.041 together with the exercise of the powers set forth in the Charter and the Constitution, this Agreement is made this \_\_\_\_\_ day of \_\_\_\_\_, 2014 by and between the Village of Richfield, Ohio ("Richfield") and the Village of Peninsula, Ohio ("Peninsula")

In consideration of the mutual promises herein contained, the parties agree as follows:

1. Purpose. Richfield will provide 24-hour, seven days per week dispatching services for the Peninsula Police Department.
2. Term. The term of this Agreement shall be three years beginning July 1, 2014 and shall continue in force and effect until and including June 30, 2017.
3. Price. Peninsula agrees to pay Richfield the following installments:
  - a. 1<sup>st</sup> year \$28,922
    - i. \$7,230.50 due 7/1/2014 and 10/1/2014
    - ii. \$7,230.50 due 1/1/2015 and 4/1/2015
  - b. 2<sup>nd</sup> year \$29,876
    - i. \$7,469.00 due 7/1/2015 and 10/1/2015
    - ii. \$7,469.00 due 1/1/2016 and 4/1/2016
  - c. 3<sup>rd</sup> year \$30,862
    - i. \$7,715.50 due 7/1/2016 and 10/1/2016
    - ii. \$7,715.50 due 1/1/2017 and 4/1/2017
4. Hold Harmless. Peninsula agrees to hold Richfield, its employees, elected officials, members of the Richfield Police Department, including its chief of police, police officers and dispatchers individually harmless from any and all liability arising out of performance of this Agreement.
5. Insurance. During the term of this Agreement, Peninsula shall purchase and keep in place general liability insurance of not less than \$3,000,000 (\$1,000,000 general liability and \$2,000,000 liability umbrella coverage) insuring against liability as a result of any act or omission of Peninsula or its officers or employees.
6. Cancellation. Either party may cancel the services of this Agreement with at least 90 days written notice to the other party.
7. Modification. Any modification to this Agreement shall be in writing and signed by both parties.

8. Assignment. Neither party may assign this Agreement without the written consent of the other party.

9. Separability. This Agreement is separable. If any provision of this Agreement is declared void or invalid by any court of competent jurisdiction, all other provisions of this Agreement remain binding.

10. Entire Agreement. This Agreement is the entire understanding of the parties. Any promise or condition not contained in this Agreement is not binding on the parties.

11. Authorization. This Agreement is entered into pursuant to Resolution No. \_\_\_-2014 of the Village of Richfield and Resolution No. \_\_\_\_\_ of the Village of Peninsula, Summit County, Ohio.
