A RESOLUTION ADOPTING AN UPDATED SCHEDULE OF FINES FOR OFFENSES IN THE RICHFIELD MAYOR'S COURT

WHEREAS, the Mayor has reviewed the existing schedule of fines to be assessed in the Richfield Mayor's Court and has determined that increases in those fines are appropriate; and

WHEREAS, a list of the fines that the Mayor has recommended is attached hereto as Exhibit A; and

WHEREAS, this Council wishes to indicate its support for and approval of the revised schedule of fines for offenses in the Mayor's Court.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the schedule of fines contained in Exhibit A be, and hereby is, approved by this Council.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason in order that the new schedule of fines for offenses take effect at the earliest possible time; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
