**A RESOLUTION TO MAKE APPROPRIATIONS FOR CURRENT EXPENSES
AND OTHER EXPENDITURES OF THE VILLAGE OF RICHFIELD, STATE OF
OHIO, DURING THE YEAR ENDING DECEMBER 31, 2008**

Be it resolved by the Council of the Village of Richfield, Ohio:

Section 1.	To provide for the current expenses and other expenditures of said Village of Richfield during the year ending December 31, 2008, the following sums be and they are hereby set aside and appropriated as follows:		
Section 2.	That there be appropriated from the GENERAL FUND:		
	a) ADMINISTRATION:		
	1. Personal Services/Benefits	\$13,000.

Section 3.	That there be appropriated from the STREET MAINTENANCE & REPAIR FUND:		
	a) Personal Services/Benefits	\$12,000.	
	b) Cost of Operations	<u>2,000.</u>	
	Total		14,000.
Section 4.	That there be appropriated from the INCOME TAX FUND:		
	a) Cost of Operations		82,000.
Section 5.	That there be appropriated from the CAPITAL IMPROVEMENT FUND:		
	a) Senior Center Repairs		2,000.
Section 6.	That there be appropriated from the LAND/BUILDING ACQUISITION FUND:		
	a) 3767 Broadview (G.R.Pedigo)		72,000.
Section 7.	That there be appropriated from the SEWER OPERATIONS FUND:		
	a) Sewer Truck (Additional Cost)	\$ 6,500.	
	b) Cost of Operations	<u>10,000.</u>	
	Total		<u>16,500.</u>

Section 8. The Director of Finance is hereby authorized to draw warrants on the Village for payment for any of the foregoing appropriations upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law to approve the same, or an Ordinance or Resolution of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with the law or Ordinance.

Section 9. In accordance with Section 4.12 of the Charter of the Village of Richfield, this Resolution No. 52-2008 shall take effect and be in force upon the approval of the Mayor.
