

**AN ORDINANCE TO AMEND ORDINANCE NO. 13-1989 AND THE SCHEDULE DATED MARCH 27, 1989 ADOPTING SALARY RATES AND WAGES TO PROVIDE COMPENSATION FOR THE CLERK OF COUNCIL AND DECLARING AN EMERGENCY**

WHEREAS: Richfield Village Council has appointed May N. (Peggy) Malone as Clerk of Council effective February 6, 1990, and

WHEREAS: The resignation of Mary L. Higley as Clerk of Council will be accepted effective February 20, 1990, and


WHEREAS: It is necessary to establish compensation rates,


NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Richfield, Ohio

SECTION 1: The Schedule of Positions and Compensation dated March 27, 1989 attached to Ordinance No. 13-1989 is hereby amended and attached hereto.

SECTION 2: This Ordinance is determined to be an emergency measure necessary for the immediate preservation of the public peace, health or safety for the reason to provide compensation for Village employees and provided this Ordinance receives the affirmative vote of two-thirds of the members elected or appointed, it shall take effect and be in force from and after its approval by the Mayor; otherwise, it shall take effect and be in force from and after the earliest date provided by law.
