

AN ORDINANCE TO AUTHORIZE AND DIRECT THE MAYOR AND DIRECTOR OF FINANCE TO ENTER INTO AN AGREEMENT WITH REVERE LOCAL SCHOOL DISTRICT AND TO REPEAL ORDINANCE 43-1980.

WHEREAS, it is desired to promote economy of operation and to secure the maximum use of employees, equipment and facilities for public recreation; and

WHEREAS, it is deemed to be in the best interests of the Village of Richfield and the inhabitants thereof to use public school facilities for recreational purposes and to maintain the same at the expense of the Village.

NOW, THEREFORE, Be It Ordained by the Council of the Village of Richfield, Ohio:

Section 1: The Mayor and Director of Finance are authorized and directed to enter into an agreement with the Revere Local School District for the purpose of providing baseball recreational facilities for the inhabitants of the Village.

Section 2: The form of the agreement is attached hereto and made a part hereof and the Mayor and Director of Finance are authorized to make payments in accordance therewith.

Section 3: Ordinance 43-1980 is hereby repealed.

Section 4: This Ordinance shall take effect and be in force from and after the earliest time allowed by law.

AGREEMENT

In consideration of the sum of \$1.00 and other valuable considerations, the receipt of which is acknowledged, and in consideration of the premises, covenants and agreements by each of the parties, the Revere Local School District, hereafter referred to as the "School" and the Village of Richfield, hereinafter referred to as the "Village" agree as follows:

1. The period of this Agreement shall be from the effective date until terminated in accordance with Paragraph Five hereof.
2. The Village will provide necessary maintenance for existing recreational facilities located on lands owned by the school and described as follows:
 - 2 playing fields located behind Richfield Elementary School;
3. The School consents and grants permission to the Village to use the foregoing premises for baseball purposes.
4. The Village will select and provide employees for the operation of the facilities and will be the sole determiner of the policy of operation and will provide direction and supervision for ball games of the citizens.
5. The effective date shall be April 1, 1986 and this Agreement may be terminated by either party giving notice of termination, to be effective no less than 30 days after the date of such notice.
