A RESOLUTION AUTHORIZING THE MAYOR AND THE FINANCE DIRECTOR TO MODIFY THE VILLAGE'S AGREEMENT WITH ARCADIS G&M OF OHIO, INC. FOR PROFESSIONAL ENGINEERING SERVICES TO UPDATE BILLING RATES FOR YEAR 2008 AND DECLARING AN EMERGENCY


WHEREAS, the Mayor has recommended approval of an addendum to the Village's agreement with Arcadis G&M of Ohio, Inc. for professional engineering services to update billing rates for year 2008.

NOW, THEREFORE BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the Mayor and the Finance Director be, and they hereby are, authorized and directed to modify the Village's agreement with Arcadis G&M of Ohio, Inc. for professional engineering services to update billing rates for year 2008 and to execute an addendum containing those new rates, a copy of which addendum is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to provide necessary professional services at the earliest possible time; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
