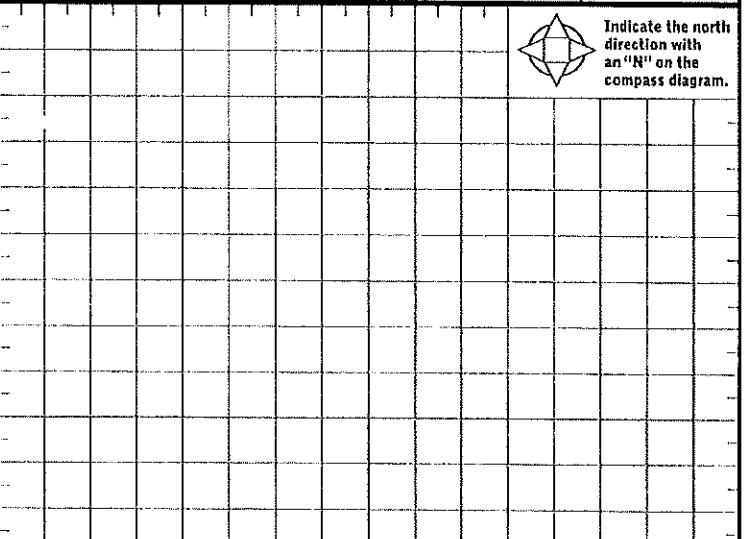

The left rear of Unit 1 struck a guardrail face on the left side of the road. The guardrail sustained substantial damage. Unit 1 sustained disabling damage.

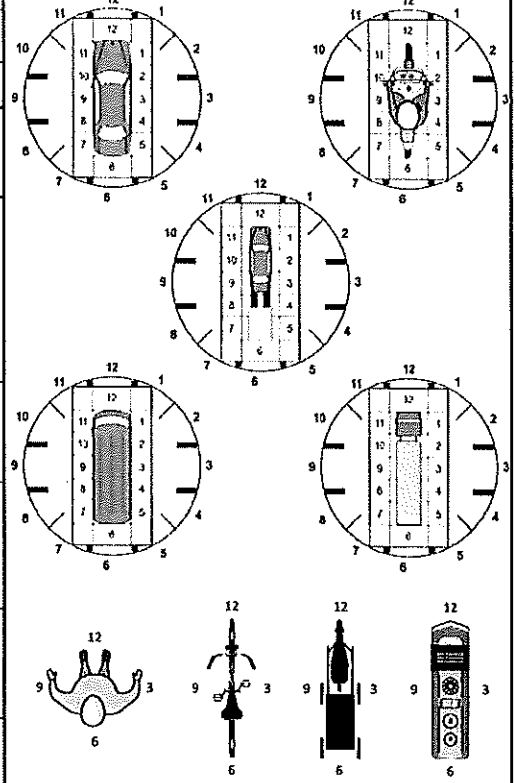

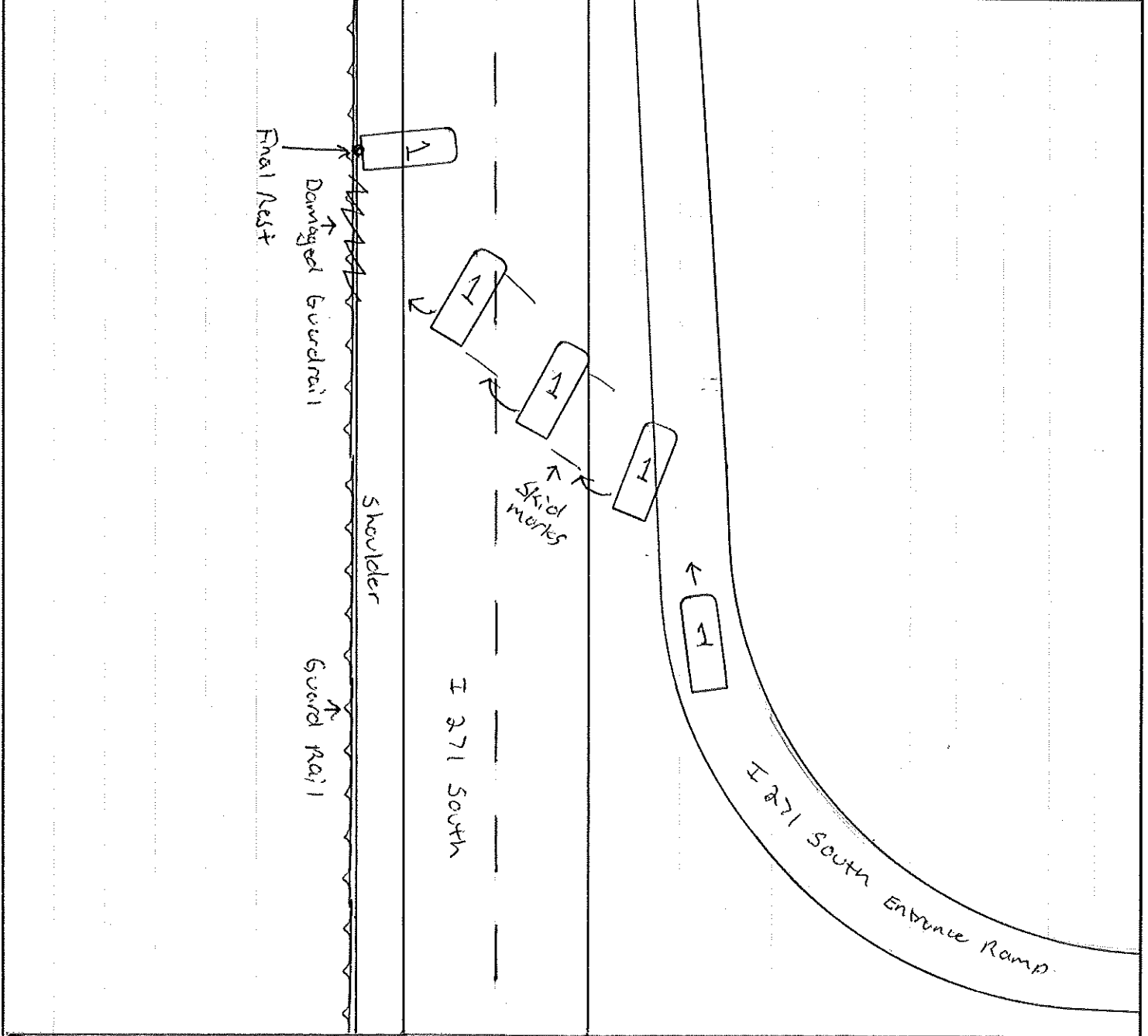
