

AN ORDINANCE AUTHORIZING THE MAYOR AND DIRECTOR OF PUBLIC SERVICE TO SELL LOTS 49 THROUGH 60 OF THE FIFTH ADDITION OF WEST RICHFIELD CEMETERY, AND DECLARING AN EMERGENCY

WHEREAS, West Richfield Cemetery is a publicly owned and operated cemetery located with the territorial limits of the Village; and

WHEREAS, prior to ownership by the Village, West Richfield Cemetery was publicly owned and operated by Richfield Township; and

WHEREAS, the Township's Board of Trustees reserved and prohibited the sale of Lots 49 through 60 of the Fifth Addition of West Richfield Cemetery until authorized by the Board of Trustees as indicated in the plat of the Fifth Addition of West Richfield Cemetery, attached hereto as Exhibit "A" and incorporated herein fully by reference; and

WHEREAS, West Richfield is running out of burial space and this Council desires to terminate the reservation of Lots 49 through 60 of the Fifth Addition and authorize the sale of such lots to the public.

WHEREAS, the availability of Lots 49 through 60 of the Fifth Addition of West Richfield Cemetery for public sale will result in 60 additional graves.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Richfield, Ohio, Summit County, State of Ohio that:


- SECTION 1. The reservation on the sale of Lots 49 through 60 of the Fifth Addition of West Richfield Cemetery as set forth in Exhibit "A" is hereby terminated.
- SECTION 2. The Mayor and the Director of Public Service are hereby authorized and directed to make available for public sale Lots 49 through 60 of the Fifth Addition of West Richfield Cemetery.
- SECTION 3. The Director of Public Service shall only allow flush monuments to be erected in Lots 49 through 60 of the Fifth Addition of West Richfield Cemetery.
- SECTION 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with legal requirements, including Section 121.22 of the Ohio Revised Code.
- SECTION 5. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further

reason that it is immediately necessary to create new burial space within West Richfield Cemetery; wherefore, provided this Ordinance receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
