A RESOLUTION AUTHORIZING THE MAYOR AND THE FINANCE DIRECTOR TO ENTER INTO A RENEWAL OF AN AGREEMENT WITH ARCADIS G&M OF OHIO, INC. FOR PROFESSIONAL ENGINEERING SERVICES AND DECLARING AN EMERGENCY

WHEREAS, the Mayor has recommended a renewal of an agreement with Arcadis FPS for professional engineering services.


NOW, THEREFORE BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the Mayor and the Finance Director be, and they hereby are, authorized and directed to enter into a renewal of an agreement with Arcadis G&M of Ohio, Inc. for professional engineering services, a copy of which agreement is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to provide necessary professional services at the earliest possible time; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

ADDENDUM NO. 8 TO AGREEMENT FOR ENGINEERING SERVICES

WHEREAS, an Agreement was entered into on April 1, 1997 by and between the **VILLAGE OF RICHFIELD, OHIO**, hereinafter called the "**VILLAGE**", and **FINKBEINER, PETTIS & STROUT, INC.**, Consulting Engineers, of Akron, Ohio, their successors or assigns, hereinafter called the "**ENGINEER**"; and,

WHEREAS, under said Agreement, the **VILLAGE** agreed to employ said **ENGINEER** to render consulting engineering and surveying services; and,

WHEREAS, this Agreement was amended on January 5, 2000 under the authority of Resolution No. 1-2000 to extend the termination date of the Agreement to December 31, 2002 and to update billing rates for year 2000; and,

WHEREAS, this Agreement was amended on February 6, 2001 under the authority of Resolution No. 14-2001 to update billing rates for year 2001; and,

WHEREAS, this Agreement was amended on March 19, 2002 under the authority of Resolution No. 36-2002 to update billing rates for year 2002; and,

WHEREAS, this Agreement was amended on December 18, 2002 under the authority of Resolution No. 102-2002 to extend the termination date of the Agreement to December 31, 2005 and to update billing rates for year 2003; and,

WHEREAS, this Agreement was amended on December 24, 2003 under the authority of Resolution No. 101-2003 to update billing rates for year 2004; and,

WHEREAS, the **ENGINEER**, previously known as Finkbeiner, Pettis & Strout, Inc., Consulting Engineers, of Akron, Ohio, is now known as **ARCADIS FPS, Inc.**, Consulting Engineers, of Akron, Ohio; and,

WHEREAS, this Agreement was amended on May 15, 2005 under the authority of Resolution No. 37-2005 to update billing rates for year 2005; and,

WHEREAS, this Agreement was amended on December 30, 2005 under the Authority of Resolution No. 95-2005 to update billing rates for 2006 and extend the termination date of the Agreement to December 31, 2008.

WHEREAS, the **ENGINEER** previously known as **ARCADIS FPS, Inc.**, Consulting Engineers of Akron, Ohio, is now known as **ARCADIS G&M of Ohio, Inc.**

WHEREAS, the Agreement must be amended to update billing rates for year 2007 for said services.
