A RESOLUTION AUTHORIZING THE MAYOR AND THE FINANCE DIRECTOR TO EXTEND THE CONTRACT WITH J&J REFUSE FOR SOLID WASTE DISPOSAL AND RECYCLING SERVICES FOR YEARS 2006 AND 2007 AND DECLARING AN EMERGENCY

BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the Mayor and the Finance Director be, and they hereby are, authorized and directed to extend the agreement with J&J Refuse for solid waste disposal and recycling services for the Village at the rate of \$9.98 per month, per household for the year 2006 and at the rate of \$10.11 per month, per household for the year 2007.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to be effective by January 1, 2006; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

J&J Refuse for Trash

10/13/05

- January 1, 2003 - contract started. \$8.38 / home / month
- December of 2003 - contract amended to have weekly recycling.
- January 1, 2004 - cost increased to \$9.35 – included increase for year and weekly recycling.
- May 2004 - cost increased to \$9.60 – to cover Summit / Akron Solid Waste Management increase. (This was an increase of \$.25 / month / household.)
- January 1, 2005 - contract increase for year - \$9.72.
- September 2005 - cost increased to 9.86. (This was an increase of \$0.14for the state law on land fills .)
- October of 2005 - current cost is \$9.86 / home / month.
