A RESOLUTION TO MAKE ADDITIONAL APPROPRIATIONS FOR OTHER EXPENDITURES OF THE VILLAGE OF RICHFIELD, STATE OF OHIO, DURING THE YEAR ENDING DECEMBER 31, 2005.
