

AN ORDINANCE ENACTING NEW FEE SCHEDULES FOR PLANNING AND ZONING, SEWER AND WATER, SERVICE, CEMETERY, POLICE, FIRE, PARKS AND RECREATION AND SENIOR CENTER AND DELCLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the Village of Richfield, State of Ohio:

SECTION 1 That the fee schedule for Planning and Zoning, Sewer and Water, Service, Cemetery, Police, Fire, Parks and Recreation and Senior Center, as set forth in Exhibit "A" attached hereto and made a part hereof fully as if by reference, be and the same hereby is, adopted.

SECTION 2 That this ordinance shall be in affect on February 1, 2002.

SECTION 3 That all ordinances and resolutions inconsistent herewith be and the same hereby are, repealed including Ordinance 5-2001.

SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare, wherefore, provided this Ordinance receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately and be in force from and after the earliest period allowed by law.
