

A RESOLUTION ACCEPTING THE BID OF GLEDHILL ROAD MACHINERY CO. FOR THE SERVICE OF EQUIPPING AND OUTFITTING THE 3-TON CHASSIS WITH A 3-TON DUMP BODY AND SNOW PLOW ACCESSORIES AND DECLARING AN EMERGENCY

BE IT RESOLVED by the Council of the Village of Richfield, Summit County, State of Ohio:

SECTION 1. That the bid of Gledhill Road Machinery Co. for supply to the Village of service of equipping and outfitting the 3-ton chassis with a 3-ton dump body and snow plow accessories, being the lowest and best bid, be, and the same hereby is, accepted, a copy of which bid is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to provide equipment for the Service Department at the earliest possible time; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.

## Dump Bodies and Accessories

As you can see both the 3-ton and 5-ton dump specifications received 3 bids. The bids for both were from the same companies. As you can see from the attached bid tabulation sheets we have listed all 3 bidders and their proposed pricing. On both bids Gledhill Machinery Co. was the lowest bid.

After a lengthy review of all the bids, it is the opinion of our Head Mechanic, Chuck Soulek, and myself as Service Director that the lowest and best bid is Gledhill Machinery. As you can see from the following chart Gledhill Machinery had exceptions.

### 3-ton dump body and accessories

### 5-ton dump body and accessories

(NOTE: All the companies will take about 4 to 6 weeks to receive the parts before construction can start.)

Although Gledhill had exceptions to the bid specifications, their proposed changes or additions either met or exceeded our specifications. (For the most part their proposal actually exceeded our specifications.)

As you can see the number of days required to complete this project is 90 days. (in excess of 4 months due to purchase of parts and the work) Therefore I respectfully request the approval of these ordinances to allow the ordering of materials and equipment to be delivered.
