

A RESOLUTION ACCEPTING THE BID OF M&M TOWING & RECOVERY, INC. FOR TOWING OF VEHICLES DURING THE YEAR 2000 AND DECLARING AN EMERGENCY

WHEREAS, pursuant to advertisement, the Village received a bid from M&M Towing & Recovery, Inc. for towing of vehicles within the Village during the year 2000 , a copy of which bid is attached hereto as Exhibit "A" and incorporated herein fully as if by reference.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Richfield, State of Ohio:

SECTION 1. That the bid of M&M Towing & Recovery, Inc. for towing of vehicles within the Village of Richfield during the year 2000 attached hereto as Exhibit "A" be, and the same hereby is, accepted.

SECTION 2. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare and for the further reason that it is immediately necessary in order to provide towing services at the earliest possible time; wherefore, provided this Resolution receives the affirmative vote of two-thirds of the members of Council elected or appointed, it shall take effect immediately upon its passage and execution by the Mayor; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.




