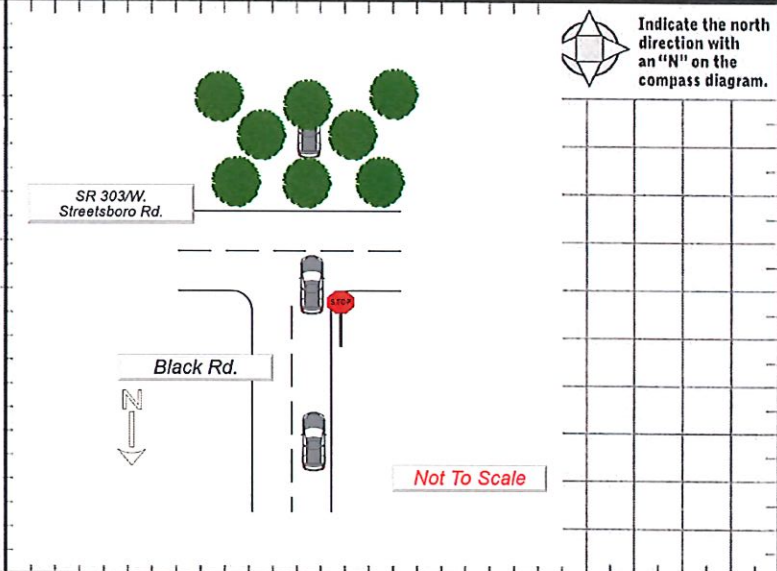

Unit #1 was traveling south on Black Rd., approaching SR 303. Unit #1 did not stop at the stop sign on Black Rd., to safely enter onto SR 303, and ran through the sign. This resulted in Unit #1 continuing over SR 303, then into the woods, south. Unit #1 became stuck approximately 40 yards in the woods, sustaining front end damage and possible undercarriage damage.

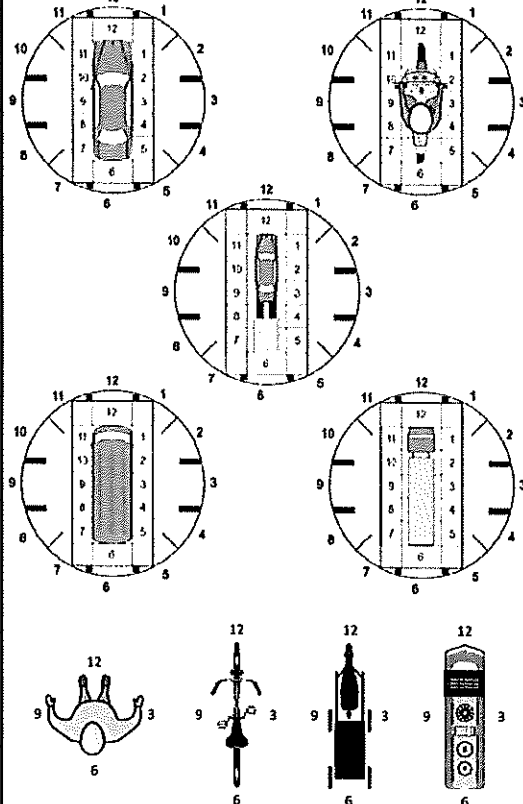
