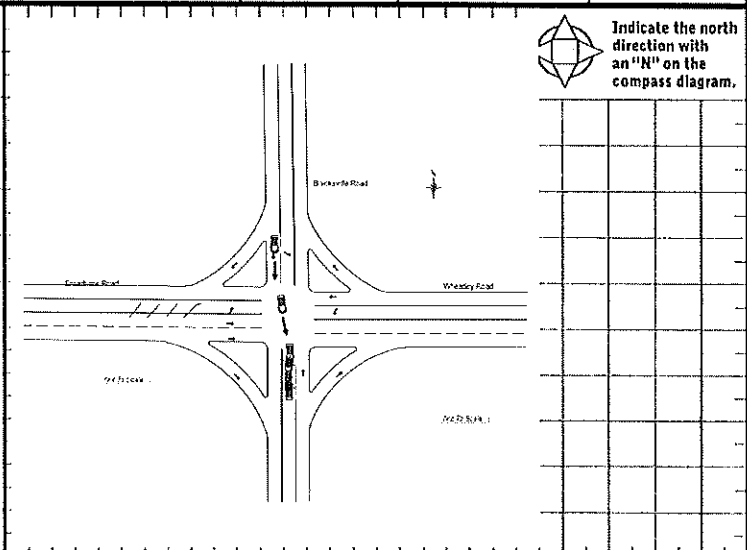

Unit #1 was traveling southbound on Brecksville Road, entering the intersection at Wheatley Road. After passing through the intersection, Unit #1 went outside his lane of travel and struck Unit #2 head-on, who was stopped in the northbound turning lane.

From this impact, Unit #2's vehicle was pushed backwards which caused the vehicle to come into contact with Unit #3. Unit #1 and Unit #2 sustained disabling damage. Unit #3 sustained damage to its front-end area, causing the air bags to deploy.

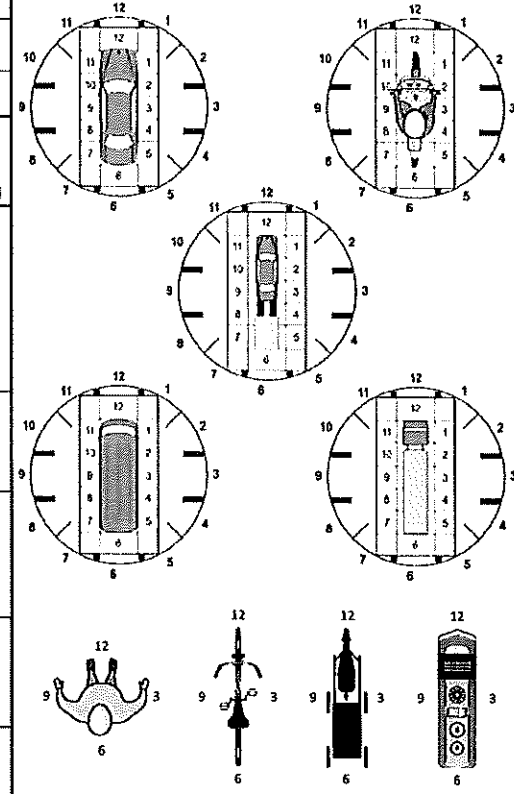
