

AN ORDINANCE TO ADOPT A SCHEDULE OF POSITIONS AND COMPENSATION FOR VILLAGE PERSONNEL, TO REPEAL ORDINANCE 10-1984 AND DECLARING AN EMERGENCY.

Be It Ordained by the Council of the Village of Richfield, Ohio:

Section 1: Schedule of Positions, Salary Rates, and Wages:
The schedule of positions and compensation, bearing a date of July 16, 1984, attached hereto and made a part hereof and the pay periods for officers, employees, and members of Boards and Commissions shall be in accordance therewith from and after July 16, 1984.

Section 2: Ordinance 10-1984 and all other ordinances or parts or sections or schedules thereto which are not consistent with the terms of this Ordinance are hereby repealed.

Section 3: This Ordinance is determined to be an emergency measure necessary for the immediate preservation of public peace, health or safety for the reason to provide compensation for Village employees and provided this Ordinance receives the affirmative vote of two-thirds of the members elected or appointed, it shall take effect and be in force from and after its approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest date provided herein.
