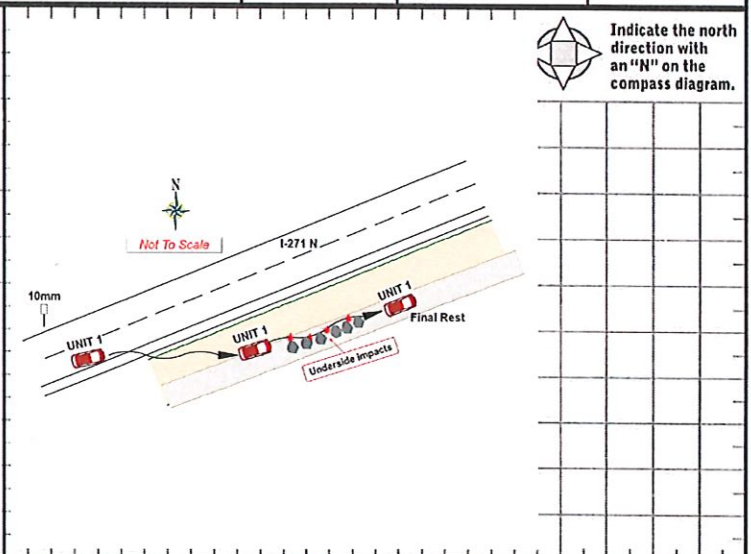

While driving along 271-N just passed the 10 mile marker the operator of Unit 1 suffered from intense flu-symptoms and passed out. While he was unconscious, the vehicle exited the lane of travel, onto the shoulder, and into the rocky ditch to the right of the roadway. Disabling damage was observed to the front/underside of the vehicle and 3 of the tires were blown out from impacts across the jagged, large concrete / boulders in the ditch.

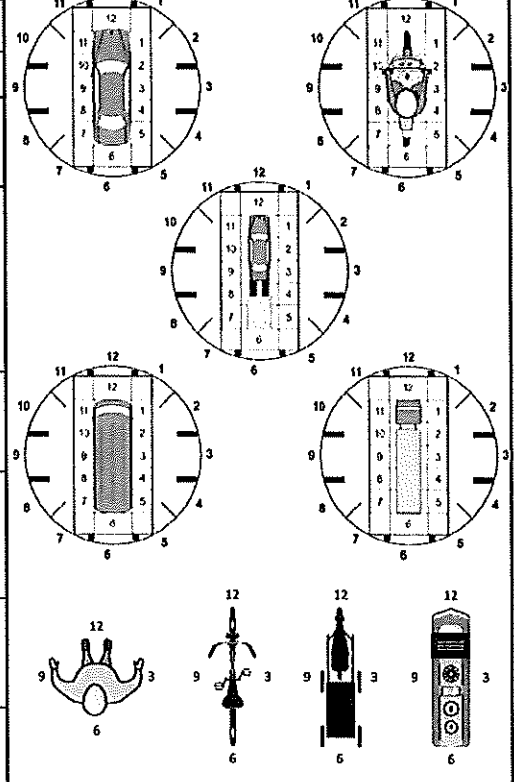
